- the consolidation of malfunctions likely to affect us.

The Corporate Technology Group, at its sole discretion, reserves the right to withdraw, at any given time and without notice, the "CTG Technical Agreement" which has just been granted to you.

Under no circumstances may your "CTG Technical Agreement" be considered as granting your Company any right whatsoever towards the companies (1) of the **TOTAL Group**. The companies of the **TOTAL Group** shall bear no liability, especially in the event of the withdrawal of this "CTG Technical Agreement".

This "CTG Technical Agreement" is limited to the activities of the companies (1) of the **TOTAL Group** which shall endeavour to select any potential bidder or bidders for supply contracts from the list of agreed companies.

Please note that the fact to obtain the "CTG Technical Agreement" does not grant whatsoever any automatic right to be called for tender. The selection of companies invited to participate in a tender remains the sole responsibility of the legal entity of the **Total Group** proceeding with such tender.


